	Notify an owner of each parcel of land, within 200 feet of the property's boundaries, of the proposed		
	changes and public hearing details. Applicant shall send/deliver <i>Notice of Public Hearing</i> (page 3) and		
	Zoning Description to said owners by certified mail or by hand-delivery, at the expense of the applicant.		
	If hand-delivered, name, address, and signatures are required on Certificate of Notification form (page 4)
