#### **Application Requirements**

The Huntsville Planning Commission meets on the 4<sup>th</sup> Monday of each month. All requests for zoning changes require a public hearing to be held during the Commission's monthly meeting. The findings of the Commission must be subsequently approved by the City Council.

Appl	icants	must:

Place a public notice in a newspaper of general circulation in the city, at the expense of the applicant,
stating the time, place, and subject of the public hearing at a minimum of 15 days prior to the hearing.
Normally this application must be filed by the first business day of the month to insure a hearing at the
regular scheduled meeting of the commission.

- □ Notify an owner of each parcel of land adjacent to the property's boundaries (including across roadways) of the proposed changes and public hearing details. Applicant shall send/deliver *Notice of Public Hearing* form and *Zoning Description* to said owners by certified mail or by hand-delivery, at the expense of the applicant. If hand-delivered, signatures are required on *Certificate of Notification* form.
- □ Notify owners of adjacent property at a minimum of fifteen (15) days prior to Planning Commission Meeting/public hearing.
- ☐ Submit the following documents to the office of the City Clerk prior to the public hearing:
  - Completed application
  - Certified mail and/or returned mail receipts
  - o Completed Certificate of Notification form

The applicant or official representative must be present at the meeting in order to answer questions the Commission members or interested parties may have.
