In consideration of being allowed to participate in any way in the 2025 Huntsville/WCCL athletics/sports program, related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury and/or illness from the activities involved in the program is significant, including the potential for permanent paralysis and death, and while rules, equipment, and personal discipline may reduce the risk, the risk of serious injury does exist.
2. The risk to have contact with individuals, who have been exposed to and/or have been diagnosed with one or more communicable diseases, including but not limited to COVID-19 or other medical conditions, diseases, or maladies does exist, and it is impossible to eliminate the risk that I could be exposed to and/or become infected through contact with or close proximity with an individual with a communicable disease;
3. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others and assume all full responsibility for my participation.
4. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and

## PARENT INFORMATION SHEET

### DEADLINES, AGES, & FEES

- Huntsville (Mitchusson Park) summer ball deadline for registration will be March 7, 2025.
- Boys must not turn 15 before May 1, 2025, or they will not be eligible to play in WCCL.
- Girls must not have turned 15 before January 1, 2025, or they will not be eligible to play in WCCL.
- Girls must have turned 6 on or before December 31, 2025, to be eligible to play this season.
- The age requirements are from the rules and regulations of the USSSA, as our WCCL league is sanctioned.
- Registrations received after March 7 will only be placed on teams that need additional players as determined by the Director and/or coaches.
- Coaches will contact parents/players of their team. This contact should take place in the first few weeks of March. If you haven't heard from a coach regarding your child by March 15, you may then contact the League Director.
- Please inform your child's coach of any allergies and/or medical issues that may affect your child while participating in practice or games.

### EQUIPMENT & UNIFORMS

- Participants will need to purchase their own ball gloves and cleats. Parents are encouraged to provide their children with their own batting helmets. Participants may need to purchase their own bat, or they may be able to share with other players on the team. The team coach should be consulted on matters concerning shared bats and/or helmets. \*\*\*Please consult the team coach or the director before purchasing any helmets or bats, to make sure the equipment meets league requirements.
- Each team is responsible for uniforms. Sometimes teams are sponsored by a business or individual to provide all or parts of uniforms, otherwise players are responsible for paying for their uniform. Each coach will provide information to parents regarding uniforms.

### PRACTICES & GAMES

- Practices will begin mid-March, and games will begin mid-April. Final games and tournament games will be concluded by the last week of June.
- Games are usually played on Monday, Tuesday, Thursday, or Friday nights. Games are not generally scheduled for Wednesday nights or weekends, except for possible make-up games.
- Games will be held in Huntsville, Lincoln, Prairie Grove, West Fork, Farmington, Greenland, Westville, and Elkins.
- Practice times will be given to the coaches based on their requests and availability of fields. Practices can be any day of the week, depending upon the coaches' schedule. Practice times or games may be moved as necessary to facilitate use of the High School Fields. High School has priority of use on fields #2 and the baseball field. League comes behind high school usage for practices and games, during the High School season.
- WCCL playing time rules: Defensively all players must have one (1) inning in the field and one (1) at bat or they must start the next game. Exceptions to this rule can be made for disciplinary reasons and/or practice/game attendance (if player does not attend, they may not play). Playing time is always at the discretion of the coaches, based on attitude, work ethic, skill, and other contributing factors.

### ADMISSION & FIELD RULES

- Regular season games do not charge admission at any location; however, end of season and All-Star tournaments will be charging a gate admission to help pay for balls, trophies, umpires, etc. for those tournaments.
- Please be aware there is to be NO drinking, smoking, drugs, or tobacco use on ANY ball field complex or facilities. WCCL has a policy against these prohibited items. The ball fields at Huntsville are on city property and we must follow their policies as well.

### COACHES

- Anyone interested in coaching will need to contact the League Director. This includes head and assistant coaching.
