- Notify an owner of each parcel of land adjacent to the property's boundaries (including across roadways) of the proposed changes and public hearing details. Applicant shall send/deliver *Notice of Public Hearing* form to said owners by certified mail or by hand-delivery, at the expense of the applicant.
